

Online Bill Pay (FACUpay)

We now offer FACUpay-an online bill pay service. Online bill pay makes it easy to control your payments and manage your account. And, you can pay your bills at any time without buying stamps or making trips to the post office.

Online Bill Pay allows you to:

- Schedule single or recurring payments
- Track your payments history at a glance
- Receive helpful e-notifications that let you know when payments are due or a bill has been paid
- Pay bills at any time - day or night
- Pay bills from multiple Fulda Area Credit Union checking accounts.

Once you have enrolled in Fulda Area Credit Union's Online (Home) Banking and if you have a Fulda Area Credit Union checking account, you may enroll in FACUpay. Simply login to Online (Home) Banking and select the Bill Pay tab to enroll. FACUpay is free provided you use the service at least once every three (3) months. If you are enrolled and do not use the service for a period of at least three (3) months, an Inactivity Fee of \$6.50 per month will apply.

eStatements-go Green!

Fulda Area Credit Union offers eStatements to our members who wish to go paperless. The advantages of enrolling in eStatements include:

- You get access to your statement faster - it's viewable as soon as the statement is generated and you don't have to wait to receive it in the mail.
- You have access to 12 months of statements online (from the date you enroll). That means if you need a statement copy, you can print one yourself rather than requesting one from the credit union and having to pay a fee for the copy.
- Online statements are official documents
- It's completely FREE

To enroll in eStatements, login to home banking and select the Statement tab. Review the terms and conditions and indicate if you wish to enroll.

Get Your Income Tax Refund Back Faster

Consider the convenience of depositing your income tax refund electronically. Usually you will receive your refund sooner if it is direct deposited.
